### Information Form

Jefferson State Community College's Educational Talent Search Program is federally funded by the U.S. Department of Education. The ETS program identifies and assists individuals who have the potential to succeed in higher education. The program provides academic, career, and financial counseling to its participants and encourages them to graduate from high school and enroll in a college of their choice. The goal of Educational Talent Search is to increase the number of youth who complete high school and enroll in the postsecondary education institution of their choice.

Due to federal requirements of the Educational Talent Search Program, an application process has been established to determine acceptance to the program. Each applicant must provide progress reports, transcripts, SAT, ACT (if applicable) and Alabama High School Graduation Exam (AHSGE) (if applicable) scores. Student records are maintained by the Educational Talent Search staff and are kept confidential. An evaluation/assessment of each applicant will be conducted to determine the need for services and potential for education at the secondary and postsecondary levels and to determine the eligibility of the applicant to receive services of the project.

The services to be provided are designed to encourage and assist participants in successfully completing high school and enrolling in postsecondary education.
